I) Object

III) Conditions of registration :

Registration for a « Total Immersion » training course will be effective after reception of the registration form correctly completed, signed and accompanied by:

- Medical certificate of fitness for any indoor or outdoor physical activity

All training courses once started must be completed.

Every trainee must be at least 18 years old except with parental dispensation.

IV) Terms of payment and payment times :

The client has to pay 30 % of the cost of the « Total Immersion » training course when the contract is signed and the balance, 70 %, before the training course is due to start.

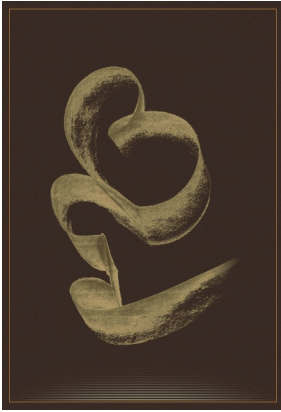

V) Rates

Rates are in euros and exclude VAT (Article 293 b, Code Général des Impôts).

BG Guillevic is registered as an Auto-entrepreneur, and as such is not subject to VAT.

Price list for « Total Immersion » training courses :

Amazonite-half a day : 150 euros

lolite-one day : 370 euros

Aventurine-three day : 1100 euros

Kersantite-five day : 1750 euros

A supplement is payable for any external activity chosen by the client during training courses of 3 and 5 days.

VI): Validation of the registration

Whatever method of payment is used by the client for the training course registration and payment will be confirmed by an email from BG Guillevic.

In case of failure to attend a « Total Immersion » training course there is no entitlement to a refund.

Any request to change the date of the training course has to be made in writing 21 days before the start date of the course.

It is forbidden to consume alcohol or illicit substances at any time during the activities of the "Total Immersion » training course.

VII) : Weather and Other Problems

In case of force majeure (natural disaster, thunderstorms, other adverse weather forecasts, etc.) BG Guillevic is entitled to postpone the « Total Immersion » training course.

The training course will be deferred to a later date.

VIII) Miscellaneous provisions

Before any legal proceedings are initiated in relation to the conditions or provision of a « Total Immersion » training course , the Parties agree to submit themselves to conciliation in an attempt to reach an amicable settlement. Failing which it will fall to the Courts in Lorient, France.
